

## Sunwing Pick Your Ticket Official Rules and Regulations 2019

The following rules apply to Rock 94's Pick Your Ticket 2019, in addition to any and all established general contest rules found on [www.rock94.com](http://www.rock94.com).

1. This contest is being conducted by Rock 94 (C.J.S.D Inc.)
2. The Contest is open to all legal Canadian residents who reside in, or within 100 Kilometers of Thunder Bay. Rock 94/C.J.S.D Inc.
