

General Contest Rules and Regulations Contests are limited to legal Canadian residents living in Thunder Bay and surrounding listening/broadcast frequency area only, 91.5 CKPR/CJSD INC. Listeners, younger than 18 years of age require the authorization of their guardian to claim their prize. For contest that consist of a concert package in the U.S. of A. in which case entrants must be 21 years of age (unless otherwise specified). Individuals who are ineligible are as follows:
